Document reference. Reference is hereby made to that certain Declaration of Covenants, Conditions and Restrictions, filed as Document No. 200006021697, and that certain Amended and Restated Declaration of Covenants Conditions and Restrictions for Lantana Ridge Unit 6, filed as Document No. 200506010772, both in the Official Records of Comal County, Texas (together with all amendments and supplements, the "**Declarations**").

THEREFORE the ARC does hereby RESOLVE that the following is and shall be its Schedule of Review Fees:


Lantana Ridge ARC -- Schedule of Review Fees

<u>Type of Improvements</u>	<u>Fee Amount</u>
Original Home Construction	\$1,000.00
Other Construction	TBD from time-to-time

- Payment of Review Fees must be made at the time plans and specifications are submitted to the ARC;
- Checks shall be made payable to Lantana Ridge Property Owners Association, Inc., unless directed otherwise;
- The ARC may vary from this schedule of fees as it deems appropriate on a case-by-case basis.



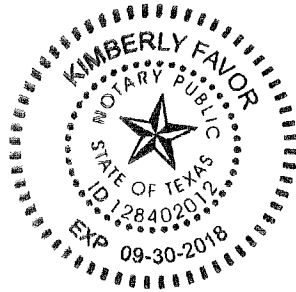
